

ARCTIC Lucky Draw Terms and Conditions of Participation 1. Description of the sweepstakes Arctic (HK) Ltd. ("Arctic") will be giving away a monthly \$1000 prize to lucky participants who purchase Arctic MX-2, MX-4 or MX-5 Thermal Compound during the participation period. The following terms and conditions apply to participation in the sweepstakes. 2. Who is eligible to participate? a.

Participation in the sweepstakes is open to anyone who purchases Arctic MX-2, MX-4 or MX-5 Thermal Compound. Entrants may also participate without purchasing a product as specified under 2d. b. Natural persons who have reached the age of majority in their jurisdiction of residence and reside in Germany, Great Britain, France, Spain, Italy, Switzerland, Canada (excluding Quebec), USA (excluding Florida and New York), Brunei, Cambodia, East Timor, Indonesia, Laos, Malaysia, Myanmar, Philippines, Singapore, Thailand, Vietnam, China, Argentina (excluding Chubut, Córdoba, Jujuy, Río Negro, Mendoza, Neuquén, Salta y Tierra del Fuego), Colombia, Chile, Czech Republic or Ukraine (excluding the Crimean territories of the Operation of the Joint Forces) are eligible to participate in the Sweepstakes. c. Each customer may only enter the sweepstakes once per drawing cycle. This restriction also applies in the event of multiple product purchases by a customer. Customers may not register multiple times using different email addresses. The drawing cycle is restarted every month. In each new drawing cycle the Sweepstake can be entered anew with a previously unused product code. d. Alternatively, entrants may also participate by filling out the entry form at [lucky-mx.arctic.ac](http://lucky-mx.arctic.ac) by entering their first and last name, full address (street, number, zip code, city, country) and email address. How do I participate? How are the sweepstakes conducted? a.

To participate in the sweepstakes, customers must scan the QR Code on the packaging of the ARCTIC Thermal Compound purchased and fill in the entry form on [lucky-mx.arctic.ac/SPECIALCODE](http://lucky-mx.arctic.ac/SPECIALCODE). b. The winner of each drawing will be determined within the first five business days of the following calendar month and be notified as soon as possible. c. The first drawing will take place on March 1, 2019. The last drawing will be held in January 2022. 4. What prizes can I win? a.

Arctic is not willing or obligated to participate in dispute resolution proceedings before a consumer arbitration board. e.
